### **Vendor Rules and Regulations**

\*Please initial at each line to agree to the following conditions set forth:

- \_\_\_\_\_ **All Vendors are required to provide a copy of their business/ tax license/ TFF in order to participate in this event.** Any vendor who does not provide these copies will not be allowed to participate in the event. (Please send copies with signed application) **Additionally, vendors will need to post their California Resale Permit at their booth during the event.**
- \_\_\_\_\_ Food vendors are required to provide **permits from Sutter County Health Department with their application** and will have their booth inspected set up day of the event. - \_\_\_\_\_ All vendor booths must be open and ready to operate when gates open. Set-up begins at 8am on the events date: **no vendor vehicles will be allowed in the event grounds prior to this time.** All vehicles must out of the event area before 10am and may not re-enter the event area until the show ends and crowd has cleared.
- \_\_\_\_\_ All vendor booths must be adequately staffed throughout the duration of the event. Members of your staff must check in with the event coordinator prior to the doors opening at the event. Only 2 admission tickets will be granted per merchandise booth and 3 per food booth. Vendors may purchase additional vendor wrist bands for \$25/day each.
- \_\_\_\_\_ Assignment of vendor space will be at the promoter's discretion. **All vendors must be contained within the 10x10 space provided at all times.** Vendors must not set up without verbal confirmation from coordination staff unless previously confirmed.
- \_\_\_\_\_ **H.A.S.O Live retains the exclusive rights to sell bottled water and soft drinks. Rio Ramaza Marina and Event Park retains the exclusive right to serve all alcohol. Vendors that do present those items for sale will have all the beverages confiscated till the end of the event.**
- \_\_\_\_\_ **All waste material must be disposed of properly.** Food vendors must dispose of used oil in authorized collection bins only. Do not dump any oil or waste on the grass or in the water. Any Vendor found doing this will be excused from the event with no refund of booth fees.
- \_\_\_\_\_ **All vendors will be responsible for their power needs.** Event coordinators will not supply additional power to any vendor. All power cords used by a vendor must be securely taped to the ground to avoid accidents. **Vendors must supply their own cords and duct tape for the event.**
- \_\_\_\_\_ **Vendors must only sell the items listed on the application. If the vendor adds additional items without the permission of the coordination staff they will be dismissed without reimbursement of booth fees.**
- \_\_\_\_\_ Children are welcome but must be supervised at all times.
- \_\_\_\_\_ Vendors Must keep their booth and area clean at all times. It will be the vendor's responsibility to clean the booth area after the event. Food and garbage left behind will not be tolerated. Vendors who do not clean their area will be subject to a cleaning fee of \$50.00.

\_\_\_\_\_ Packing up before the show has ended is permitted, however, no cars will be allowed to re-enter the event until all crowds have cleared.

\_\_\_\_\_ The event will take place outdoors and the vendor should plan accordingly. The event will nto be cancelled due to weather. No refunds will be given if the vendor chooses not to participate.

\_\_\_\_\_ Any vendor that does not comply with these rules and regulations will be asked to leave the premises. Any hostile or destructive action performed or permitted by vendor and/ or co-vendor will not be tolerated and will result in dismissal from the event.
